NEW MEDICAL PLANS BEING OFFERED

Our open enrollment period for changing your health benefit plans offered through California's Valued Trust (CVT) is **August 8 – September 11, 2019**. The effective date for changes to take effect will be October 1, 2019. **If you do not wish to make any changes, your current coverage will remain in place and you need to do nothing.**

NEW MEDICAL PLANS – EPO SUTTER HEALTH/AETNA

Three new medical plans are being offered through CVT. Please read the attached information carefully regarding these new plans as they may provide a lower cost alternative.

- EPO stands for “Exclusive Provider Organization”. As a member of an EPO, you can use doctors and hospitals within the EPO Network only, you cannot go outside the network for care. **There are no out-of-network benefits.**
- Visit **sutterhealthaetna.com** for the most up to date information on participating doctors and facilities.
- **Prescription drug coverage:** The EPO pharmacy benefit will work just like the pharmacy benefit on the PPO plans.

Sutter Health/Aetna and CVT representatives will be at the District Office to review these new EPO plans and answer questions. Two session times are available (same information covered in each). Snacks and raffle prizes will be available for both sessions.

All plans remain composite plans (coverage for all family members who qualify). Comparisons for each plan are attached. In addition, we have added similar plan comparison sheets that will allow you to compare your plan with other similar plans “at a glance”. We hope you will find this helpful.

Please **carefully review the attached matrix for costs and comparisons** on the plans being offered. The rate sheet shows the premiums effective October 1, 2019 and the resultant payroll deductions or cash back. Any rate increases will be reflected on your September 30, 2019 paycheck. *Please note: Deductibles run on a Calendar Year - January-December.*

Please use MyCVT (information attached), the online system, to set up your account and to make benefit changes during open enrollment. There are no forms to complete by using the My CVT system. Please remember to check that all dependents are listed before exiting the online portal.
