



Buckeye Curbside meals

Student Nutrition Services is excited to provide daily curbside meal pick ups at each school site. Our hours are from 10:45-12:15 Monday-Friday following school calendar.

Parents can pick up student's meals for all enrolled BUSD student's at one site. You do not have to drive to each of your child's schools. We will not be able to feed siblings who are not enrolled in Buckeye Union School District, this is for student's only.

Meal pick-up process

Parents/guardians will need to show proof of BUSD enrollment at meal pickup. (Student ID, Report Card) We will have a roster and can look student up by name but ID would help us.

Meal costs and payments

Meals will be charged to the student's account according to the student's eligibility status (free, reduced or paid) and/or the eligibility designation of their home school

There must be sufficient funds in a student's meal account to cover the cost of meals.

- We prefer parents to pay online
- If you want to pay by check we will take a check with clearly marked student name in notes section at curbside.
- We will be unable to accept cash in the distribution curbside line, you can arrange to pay by cash by contacting our Nutrition Services office at 530-677-2277 Ext. 1247

Frequently asked questions

Are meals available to any child under 19 years of age as was allowed during the spring 2020 semester and summer meal service?

Different regulations applied during the spring district shutdown and summer meal service program. Meals served during the school year through the NSLP are only available to enrolled BUSD students with a valid student ID. Parents/guardians will need to show proof of BUSD enrollment at meal pick up. (Student ID, Report Card,) We will not be able to serve siblings that are not enrolled in BUSD.

POSSIBLE CHANGES There is current legislation that MAY allow us to serve all student's for FREE. At this time, the legislation has not been passed. We are hoping the "Pandemic Child Hunger Prevention Act" is passed quickly which will allow us to serve your students free meals during these uncertain times. Stay tuned as things may change quickly and we will update you as soon as we can.

Unless the legislation passes and we receive a waiver from the USDA that would allow continuous free meals we plan to offer breakfast and lunch meals based on student eligibility.

What if my students require a diet modification?
