School Description and Mission Statement (School Year 2019-20)

Principal's Message

Buckeye Elementary School, a 2010 California Distinguished School and 2017 STAR Honor Roll School, is home of the Bobcats. Built in a wide open oak woodland, our campus is beautiful and inviting. For many years Buckeye School was the only school in a one-school district. Located in Shingle Springs, a rural part of the gold country, our school is rich in history and is the heart of our community. Although we are the oldest school in our community, we have consistently maintained a commitment to innovative instruction and excellence in education.

Our school is equipped with the latest in educational technology that inspires our staff and engages our students. We are particularly proud of a full computer lab, internet connected student computers in each classroom, teacher laptop computers, document cameras, and Promethean interactive boards in every classroom. Each 3rd-5th grade class has a Chromebook cart which allows each student to have their own laptop to work on school projects. In addition there are banks of Chromebooks in our K-2 classrooms. We have had extensive professional development in the use of technology to enhance student learning. All of this adds to an exciting learning and teaching environment.

Our school demographics reflect the rural community that is truly Buckeye. We provide a wide variety of programs that support the different needs of our students. Buckeye Elementary receives additional funds through the Title 1 program which we put to work for all students to meet or exceed standards. Bobcat RAP (our signature intervention program) provides students with differentiated instruction in the area of reading. We are also able to hire two reading teachers that push in to each classroom for part the of the school day to give students additional small group reading opportunities. We also have a math intervention teacher to work in our 3rd-5th grade classes four days a week to support the current learning and give more small group support. These programs were added to address our student's needs and readiness for school. Our site houses the district's food service facility and our breakfast program is popular with many Buckeye students.

Additional enrichment is now becoming a cornerstone of Buckeye. We have an elementary band program that we provide before school for interested 4th and 5th graders. We also have a lunchtime STEM Club offered two days a week during lunch and recess for students in 2nd-5th grade. This year we have added a Robotics Team for some of 4th and 5th grade students after school. Our Cross Country team runs in the Fall and competes at a high level against schools across our county. This year we've also added a 4th/5th grade girls basketball team and 5th grade boys basketball team. In addition, our school participates in Unified Sports which gives our students with special needs an opportunity to participate in organized, competitive sports such as soccer and basketball alongside their typical peers who act as mentors during practice and games. Finally, we have many lunchtime clubs that have been created by our students including a chess club, book club, and computer club.

School Profile

Buckeye Elementary School is one of six elementary schools and three middle schools in the Buckeye Union School District. The district was established in 1858 and currently serves the communities of Shingle Springs, Cameron Park and El Dorado Hills in El Dorado County.

During the 2018-19 school year, 385 Kindergarten through fifth grade students were enrolled at the school, with classes arranged on a traditional schedule.

The Buckeye Union School District is proud of the facilities that are provided for students and families. Each year parent surveys indicate that they are pleased with the condition of the schools.

Buckeye Elementary was originally constructed in 1957 and is comprised of 25 classrooms, one multipurpose room, one administration building, one library, one staff room, one computer lab, and two playgrounds. Measure K allowed for remodeling in 2009 of the library and computer lab; staff and workroom; district-wide food services kitchen; refinishing of sidewalks and blacktops; and technology addition of Promethean boards and classroom computers. While reviewing this report, please note that even minor discrepancies are reported in the facility inspection process. The items noted in the table have been corrected or are in the process of remediation.

The school provides a safe, clean environment for students, staff, and volunteers. The school is always in compliance with all laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. Fire, earthquake, and disaster drills are held regularly throughout the school year. The School Site Safety Plan was last reviewed and updated in December 2019 by the School Site Committee. All revisions were communicated to both the classified and certificated staff. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Students are supervised before-and- after school by certificated staff and yard duties supervise students during lunch and break periods. There is a designated area for student drop off and pick up. Visitors must sign-in and wear a badge while on campus.

As part of the growth process, opportunities for training and staff development are provided at both the District and individual school sites to administrators, teachers, and classified staff. The District offers three staff development days annually, where staff members are offered growth opportunities in curriculum, teaching strategies, and methodologies.

The 2018-2019 staff development focus included: Common Core State Standards in Science, differentiated Instruction to meet the needs of a variety of learners in the classroom, use of technology in the classroom, and review of data related to state and District level assessments, learning targets, PBIS, and Teacher Home Visit Project.

Staff is offered support through the Peer Assistance Review (PAR) program and new educators can find mentors through the Teacher Induction Program (TIP).
